Subject: DPS2UA proposals to the NCEC roaming resolutions under public consultations

Dear NCEC colleagues,

Considering the meetings held in Brussels last week (16-18 July 2024), which provided an excellent opportunity for informal discussions with the representatives of the EC regarding the text of by-laws published by NCEC for public consultation, we concluded that certain provisions require some clarifications. In our expert opinion, which we hope that you'll share, the clarifications inserted in the text of the attached documents will enhance the assessment of the implementation of the EU roaming acquis in Ukraine and provide greater clarity for those who will need to apply the resolutions when the time comes.

Considering the above-mentioned, on behalf of DPS2UA project, we would like to submit our proposals to the five NCEC's draft resolutions on roaming, published by NCEC for public consultation, in particular:

- 1. Resolution "On approval of the Rules for providing regulated retail roaming services"
- 2. Resolution "On the approval of Conditions and rules for providing wholesale access (including wholesale charges for regulated roaming services) to public mobile electronic communications networks for providing regulated roaming services"
- 3. Resolution "On the approval of the procedure rules for applying the policy of fair use to the consumption of regulated retail roaming services provided at the applicable domestic retail level of prices in order to prevent abusive or anomalous use of regulated retail roaming services by roaming customers in the Ukraine EU roaming zone and the imposition of surcharges for the consumption of retail regulated roaming services in excess of any limits under any fair use policy"

- 4. Resolution "On approving the procedure and methodology for assessing the sustainability of the provision of retail regulated roaming services at domestic prices"
- 5. Resolution "On establishment of single maximum rates for termination of voice traffic on mobile and fixed communication networks, coming from numbers of the European Union or numbers of Ukraine, which are roaming in the EU, which are charged by wholesale service providers for the provision of voice termination services".

We reflected our proposals in the attached documents in both Ukrainian and English languages for your consideration.

If any additional clarifications or explanations from our experts are required, we'll be happy to provide them.

We wish you a successful conclusion of the public consultation for these five by-laws and a smooth and successful granting of the EU internal market treaty for the roaming sector.
